



## **Andover Voter Service Update**

The Andover Candidates' Forum on Saturday, March 12 was attended by more than 50 people. We were pleased that all unopposed candidates attended in addition to the candidates for contested races. It wouldn't be possible to organize these events without the collaboration of many willing town staff members and volunteers.

Heather McNeil was an excellent moderator, and Andover High students Theresa Cloutier, Emily Granoff, and Ronan Maye provided cheerful and competent help with timing and question collecting.

President Kerri Ford collected email questions on her iPad. This was the first time this technology was incorporated into our procedures. The League web address was announced at the beginning of the broadcast and at least one question was submitted via email from a TV viewer.



Our team of question sorters, Cynthia Barakatt, Sandy Gleed and Maureen Sundberg ensured that many important topics were covered and that audience questions were answered.

The League is grateful to the candidates who shared their time with the voters, to Memorial Hall Library, for allowing us to use their facilities, and to Andover Community Access & Media for broadcasting the event live and for taping it for rebroadcast and posting online.

#### **North Andover News**

The League contingent in North Andover has been busy with a Candidates Forum, a visit to the Senior Center as guests of their Lecture Series, and preparations for a series of cable shows to educate voters prior to our Town Meeting which begins on May  $10^{\rm th}$ .

Our Candidates Forum took place on March 9<sup>th</sup> and featured the three candidates for two seats on the School Committee - Stanley Limpert, Stanley Frank Novak, and Brian Gross. Also present were three of the four Board of Selectman candidates vying for two seats - Tracy Watson, Richard Nardella, and Donald Stewart. Joe Edward Smith had been ill and was unable to attend. Also participating were Robert Bonenfant and Frank Rossi who were challenging each other for one seat on the Greater Lawrence Technical School Board. Questions were solicited ahead of time from the public and from League members. Stefani Traina was our moderator, and Sandy Gleed did hours of work along with Brian Frazier and volunteers from NA CAM to film and rebroadcast the event several times prior to the election which took place this past Tuesday. Phila Slade and I were time keepers and greeters.

Winners in our local election included Stanley Limpert and Brian Gross for School Committee, Don Stewart and Tracy Watson for Board of Selectman, and Frank Rossi for the GLTS seat. Ted Snell also won as he was unopposed for a seat on the Housing Authority. The swearing in of candidates is being delayed, to my knowledge, as the Board of Selectman and GLTS races were so close, determined by 12 or fewer votes.

We also visited the North Andover Senior Center as part of their Lecture Series. Kathy Stevens, Sandy Gleed, Phila Slade, and I spoke about the League, its history here in North Andover, and current projects including our work to bring nonpartisan information to voters via NA CAM. The discussion was lively including comments about CPA funding; it was recommended as a possible study our League could do in North Andover in the future. We also discussed that the League takes Voter Service very seriously in trying to bring balanced and nonpartisan information to voters. There was a discussion regarding the need for more nonpartisan shows on NA CAM as well as shows depicting both liberal and more conservative perspectives. And we encouraged the attendees to be part of the process by putting articles on the warrant and creating shows for NA CAM. Sandy spoke about the shows she has had a large part in producing over the last year on behalf of our joint Andover/North Andover League. These include:

- the 2010 Census with Town Clerk Joyce Bradshaw and then Representative Barbara L'Italien,
- Preparing for Annual Town Meeting with Town Moderator Charles Salisbury,
- the Legislators and Leaders Forum, co-sponsored with Stand for Children, that was the 1st live cable production in the rotunda at Stevens Memorial Library,
- Preparing for our Fall Special Town Meeting with Finance Committee Chair Mark Rodgers,
- a Meet and Greet with candidates running for state office in November,
- Running for Public Office Workshop,
- a show on the 90th Anniversary of the League of Women Voters, and
- the Candidates Forum discussed above.

We would like to encourage more people to use this medium for information as busy lives and other obligations make it difficult to keep informed about the goings on in town government. We want to make keeping engaged and informed easier.

Our next endeavor is preparing voters for North Andover's Town Meeting which begins on Tuesday, May 10<sup>th</sup> at 7:00 PM at the North Andover High School. We will be doing a series of interviews with town officials to air on NA CAM leading up to Town Meeting. So stay tuned to the League website as well as to NA CAM stations 24, 26, and 28 for

Verizon customers and 8, 10, and 22 for Comcast customers.

## **Andover Town Meeting**

The first night of Town Meeting is Wednesday, April 27 at the Collins Field House.

The League is trying some new ways to help educate voters this year. We'll be organizing a cable television show with **Lisa Schwarz**, Senior Town Planner, and **Jacki Byerley**, Town Planner, of the Andover Planning Division that will provide information about three warrant articles which will be coming up at Town Meeting. The three articles being presented:

ARTICLE 31. Zoning By-law Amendment - Off-Street Parking Requirements

ARTICLE 39. Zoning By-law Amendment - Open Space Residential Design (OSRD) Special Permit

ARTICLE 47. Zoning By-law Amendment - Political Signs

The show will be taped on April 6. Stay tuned for details about when it will air.

## **Andover Town Meeting Preview**

The League will also host a Town Meeting Preview of other warrant articles on Wednesday, April 13 at 7:00 p.m. in the Board of Selectmen's room, Town Offices. Various town officials and others have been invited to make presentations, and League members will pose a set of questions about each warrant article to help elicit information about financial implications and other issues. Audience members may ask questions, as well. The format varies from previous years when League members would research articles and present the pros and cons of each. The program will air live on Andover Community Access & Media stations and be taped for rebroadcast and posting online.
