Andover Budget Forum - April 10

Prepare for Annual Town Meeting by attending a Budget Forum, planned by the League of Women Voters of Andover/North Andover, on April 10, 7:00pm, in the School Committee Room, Second Floor, 36R Bartlet Street. The Budget Forum brings together leaders of town government to discuss issues and answer citizen questions around the FY 2014 Budget.

Jon Stumpf, Finance Committee, will provide an overview of the key drivers of revenues and expenses and discuss components of the budget. Town Manager Buzz Stapczynski and Superintendent Dr. Marinel McGrath will present notable changes in anticipated revenues for FY2014 and look at specific cost increases as well as efficiencies and cost reduction efforts. The chair of the Board of Selectmen, and the chair of the School Committee will discuss the general budget situation and look at issues requiring resolution prior to Town Meeting.

Each year, the League organizes this opportunity for residents of Andover to interact directly with town leaders in order to learn more about the budget, ask questions, and voice concerns in advance of Town Meeting. The forum will be televised live and taped for rebroadcast on Andover TV, Comcast Channel 99 and Verizon Channel 43.

North Andover's Annual Town Election Results and Stay Tuned for Town Meeting Preview Programming

It was a quiet election day on March 26th. Only 9% of the 19,177 registered voters turned out to choose one member of the Board of Selectmen, one School Committee member, and one member of the Housing Authority. Rosemary Smedile, the incumbent, ran unopposed for the Board of Selectmen. Mary Beth Soucy also ran unopposed for the seat she held on the Housing Authority.

The only contested race was for School Committee. Christine Allen decided not to seek re-election. Thus, two candidates emerged, Mark Mezzina and Zora Warren. Ms. Warren won receiving 68% of the votes compared with Mr. Mezzina's 31%. We hope you were able to watch the League of Women Voters Candidates' Forum and get out to vote in our local election.

Next, stay tuned for Town Meeting Preview Programming on North Andover CAM. You can get informed by first attending this month's Finance Committee Public Meeting regarding the budget which will be on Tuesday, April 9th at 6:45 PM at the Town Hall. North Andover's Town Meeting begins the evening of Tuesday, May 21st.

It's A Life Skill: Debating!

I am a parent and coach with the James Otis Communicators, a speech and debate club in Andover with members from the Merrimack Valley and North Shore. We are affiliated with the National Christian Forensics and Communications Association (NCFCA) and Haverhill Area Homeschoolers as well as North Shore Christian Homeschoolers (NSCH).

April, NCFCA will hold its regional invitational speech and debate tournament not far from here in Concord, NH. We are in need of many community members to judge speech and debate events during the tournament. There are three categories for speech (Individual Events) - Interpretive, Platform, and Limited Preparation; and two types of debate, Lincoln-Douglas Value and Team Policy.

Do you have three hours to give? No experience as a judge is necessary and a short training session will be given. Adults, of all ages, from all walks of life, can offer our students a variety of comments and perspectives. All judges must be at least 18 years old and must not have been eligible to compete in any NCFCA event during the current season, and must not be currently enrolled in high school. Parents may bring their own students to watch. *{Quiet younger students are always encouraged to watch with their parent(s)!}* Judging can count toward Community Service Hours for several organizations.

The myriad benefits for students participating in these events include: the opportunity to learn how to listen to others; weigh the information presented; speak their minds politely and courteously; critical thinking; impromptu speaking; research; checking the validity of facts; considering the sources; and examining bias.

I, personally, chose to educate my children at home and, yes, all of my children participated in speech and debate club and tournaments, even though it was NOT anyone's first choice. There has been our fair share of blood, sweat, and tears over the preparation and performance, participating completely outside of our comfort zones. And, YES, it is worth the work! For example, my very quiet, reserved daughter was called for jury duty when she was not yet 20 years old. She was placed on a jury that lasted three days. She told me she was easily able

to follow the arguments and even clarify points during deliberations. In the end, she came home pleased with her participation. She told me how glad she was that I had required her to engage in NCFCA Debate tournaments. She was disappointed that the attorneys did not have to follow the NCFCA rules against *Ad hominem*!

The NCFCA Region 10 Invitational Tournament takes place April 22-25, in Concord, NH. It recently dawned on me that members of the League of Women Voters would make super judges!!! The students rely on the judges' valuable feedback for improvement, growth, and encouragement. Community judges offer various points of view and expertise, not just the parental input they have already heard. No experience in either speech or debate is necessary. Friendly volunteers will give you a short orientation and ... cookies! Please consider coming to judge and spreading the word about this speech and debate tournament.

Both he and Ms. Saunders provided excellent instruction regarding effectively lobbying our legislators and how to maintain our energy and passion for the long haul which is usually what it takes.

The event began with a message from LWVMA President, Eva Valentine, followed by the featured speakers. The Program and Action Committee presented the current status of their bills and the talking points to be used when lobbying legislators. Once the general meeting was adjourned, League members made their way to their respective representatives' offices. Our group went to visit Sen. Finegold and Rep. Lyons both of whom were not in their offices.

VP of Program and Action Committee, Carole Pelchat explained that while there are many bills the committee monitors, the ones on the list for today happen to be timely at present so they are receiving the benefit of the focused effort of Day On the Hill. It is interesting to point out that the "Call to Action" emails that come either directly from LWVMA or from LWV of A/NA regarding bills at the state level originate here with this committee who so diligently monitor and advocate on behalf of the League.

The LWVMA staff did a terrific job organizing and running the event and materials provided were well-designed and very helpful.

Needham League Event on April 25 The Influence of Money on Our Democracy: What Can We the People Do

Questions from the audience will follow the presentation. Seating is limited to the first 300 people. The event is free and open to the public.

Lexington League Event on April 5 Our State Budget: Making Tough Choices

The League of Women Voters of Lexington's First Friday Forum on April 5 will provide an interesting look at the Massachusetts state budget and its effect on Lexington. How do we, as a Commonwealth, choose to invest our resources to strengthen our communities, support vulnerable residents, and build a vibrant economy?

Luc Schuster, Senior Policy Analyst, Massachusetts Budget and Policy Center, will show, through data prepared by MassBudget, how past tax policy choices have contributed to the state's ongoing fiscal crisis, leading to painful cuts to many programs. Mr. Schuster will also outline how these decisions have affected programs designed to support cities and towns: general local aid and Chapter 70 education aid. A discussion will follow with Senators Michael Barrett and Ken Donnelly and Representative Jay Kaufman about ways the state could improve its revenue system.

This is the sixth in a series of 2012-2013 First Friday Forums hosted by the League of Women Voters of Lexington to promote awareness and understanding of public policy issues. Coffee will be available at 9:15 a.m. and presentations will begin at 9:30 in the Community Meeting Room on the lower level of Cary Memorial Library, 1874 Massachusetts Avenue. The library is easily accessible by Lexpress and from the Minuteman Bikeway. For more information, contact the League at 781-862-6435. All League forums are open to the public at no charge.
