### *This Month's Activities:*

First, on October 26, Jean Sideris, Outreach Coordinator for the Union of Concerned Scientists, spoke about "Extreme Weather, Global Warming and Your Health" at The Edgewood Community in North Andover. Jean's presentation to approximately 50-60 residents and League members focused on the interplay of our environment and human health and she fielded many thoughtful questions. We are grateful to Amy Janovsky for coordinating this amazingly successful event.

Second, a well-attended League-sponsored informational forum about the proposed youth center article took place on Nov 2. Residents learned about the current status of the project prior to the special town meeting scheduled for Dec 5th. At the BOS meeting on Nov 14th, they voted to recommend approval, 4-1.



The presentation covered myriad topics related to the town's financial health and future. Town boards met with Frazier afterwards for a debt workshop.

Thank you to all of you who took action and voted at the North Andover Special Town Meeting on Tuesday, November 15th. All articles passed with the exception of Article 3 regarding the transfer of funds to the stabilization fund. Here are some other details of the voting results.

Article 1 regarding the school construction projects - *Passed unanimously.*

Article 7 regarding the appointment of members to the Board of Selectmen to fill a vacancy - *Passed with an amendment that requires public comment and input prior to the appointment.* So stay tuned!

Article 9, the local option meals tax - *Passed by 7 votes.*

The town also voted to pay unpaid bills from the prior year, to petition the General Court for an age exemption for a woman to become eligible to be appointed to the position of police officer, among other decisions.

The Town Meeting did not get the chance to discuss or act on moving money into our stabilization fund as the Board of Selectmen recommended favorable action while the Finance Committee was split on its recommendation.

## **Recycling & Composting Take-Off at Andover High School**

Hannah Krieger, AHS 2011 student, launched a recycling and composting program in Andover High School's cafeteria in September with great support from the AHS Administration and custodial staff. She worked closely with Candy Dann, a regional recycling coordinator for the state of Massachusetts.

Hannah started the project as her "Senior Exhibition" at Andover High School. The Senior Exhibition program is an opportunity for seniors to use time during the school day to take on specific projects of their own. Many

students take on a project focused on a certain cause they are interested in, attempt to create or build something they are curious about, or simply do some kind of structured research on a specific topic that captures their attention. Hannah decided to start a composting and recycling program in the school's cafeteria.

Hannah spent her entire senior year planning for the program to start this fall, after she would have already left the high school. The first large event that helped to kick off the program took place last April. It was called a "Waste Audit" and had two purposes: to raise awareness and to collect data. The Waste Audit consisted of taking a day's worth of trash, and sorting through it to find out what items could have been recycled or composted that day. The audit took place on the front lawn of AHS and was quite the sight for students to see. The piles of trash naturally inspired students to think about how much waste the cafeteria actually produced each day and how much waste they could be recycling and composting.

This fall, Hannah, League-member Candy Dann, and other members of the "Compost and Recycling Team" prepared the high school for the start of recycling and composting by presenting the project at Freshman Orientation and at each

grade's class meeting during the first week of school. The Compost Team also asked Coach Fazio to energize the students by leading them in a chant "Blue + Gold = Green" at each lunch during the first day of school.

The program started successfully at the beginning of this school year. There are eight waste sorting stations in the cafeteria where they may separate their remaining food and containers into liquids, recyclables, compost, and trash. The Andover Recycling Committee and DPW have supported this program with funding and time. The support from students, staff, and faculty has been tremendous. The early results have been exciting: approximately a 50% diversion, by weight, of the trash!

The key to the program's success so far has been attributed to having volunteers in the cafeteria each day from 10:40 a.m. until 1:00 p.m. to monitor the waste stations and answer occasional questions about how to sort all remainders appropriately. The volunteers, known as the Compost Team, receive a handout explaining the composting and recycling process before they arrive to help out at the cafeteria. The handout provides virtually all the information that a volunteer will need. Volunteers have two roles: to provide oversight so that students know it is still important to separate and then, second, to thank the students.

Volunteers also walk around to check on the eight stations and occasionally jiggle the recyclables bin and compress the compostable items and trash within the bins. Hannah and Candy hope to gain support for this program by reaching out to the Andover community through outlets such as this newsletter. This is a great way for the people who volunteer to help students do the right thing, to get an up-close look at the high school, and to support a program that will perhaps be adopted by other Andover schools as time goes on.

By encouraging people to volunteer for one day, Hannah hopes to find a group of volunteers who can commit to a weekly or monthly lunch block and ensure the continued success of the program.

## **Report from Region 4 Presidents' Breakfast**

Excerpted from meeting minutes.

Stefani Traina and Ann Cobleigh attended a meeting with other Region 4 Leagues. A/NA, Valerie Osborne of Gr. Haverhill and Carole Pelchat of Gr. Haverhill and LWVMA board, Carin Kale of H/W, Lee Mondale of Marblehead, Ann Gyles of T/B/M, Muriel Zaginailoff of LWVMA, and Ruth Race. Unfortunately representatives from Cape Ann and Swampscott could not be with us that day.

Reminder about the LWVMA Presidents' Breakfast on October 29 at the Needham Historical Society.

National Education Study (LWVUS) -- Marblehead and Hamilton/Wenham, the two leagues in our region participating in the study, expressed concern about the types of questions for consensus in the study. It is felt there is an overwhelming amount to be discussed and difficult at that, questioning the efficacy of doing national studies and are national studies fast tracked too much, making it very difficult for locals to engage in. All hoped that our opinions could be conveyed to national, via this report perhaps.

Voters Service -- Our group was most enthusiastic about the LWVMA's idea to coordinate a statewide high school voter registration campaign. In Beverly, BevCam (local cable access) to help produce television interviews for the fall election. Legislative News -- Carole brought us up-to-date on the casino issue, which seems to be a foregone conclusion, with the "happy hour" amendment probably turned down. Location of casinos is still in flux. Also, it was hoped that the revised bottle bill might still pass.

Review of fall-out from the negative ads on Scott Brown last spring -- Most of the group felt that their locals were surviving reasonably well after the problem. Some have lost members, but none reported difficulties with town/city relations. Other - There possibly may be a need for League action in Lawrence if there were difficulties with an outside group wanting to film voters at entrances and exits of the polls. However, we were not notified.

## **National League - LWVUS Activities**

### **LWV Calls on President to Make Nominations to the FEC (Federal Election Commission)**

In a letter and press conference, the League and coalition partners called for changes in the dysfunctional Federal Election Commission.
